- The pole has been established at the Valley Club rec area cart path.
- First time the Annual Meeting at the Mountain Humane however, no zoom there.
- The Road Fees 3<sup>rd</sup> Installment has gone out and due 103124.
  - Pretty good results on payments
  - One on list tht have not paid is VCI however, they are paying 2<sup>nd</sup> this wee and 3<sup>rd</sup> at the end of the month.
    - They need to budget for 2025 and would like number as soon as possible
  - o Buttercup road was difficult but better now that it is done.
    - South end exit (per Zach with VCI) they will still need to work on South end to prevent future ice built up on road. The county did not correct the drainage issues, they just covered the road.
  - o Thanked John Taylor to get the work done for Streamsside Sealcoat. It looks very nice
  - Future Board Meetings once a month to be changed to once a quarter. Meetings can be done
    whenever a need for a meeting
  - Reminder if you have something on the agenda .... It needs to be addressed at least 2 weeks before the meeting to be added to the quarterly Director meeting agenda.

4. Road Report Janet

- Road Work Continue to next spring VCOA pushed off New County Engineer required additional documentation before County would issue approval and permit for the road work.
- As of now the 2024 the last proposal will be \$100k more than was estimated.
- Plan to get it done next spring provided VCOA members can get the permit from the County
  - Ann suggested that new members should be able to get a new proposal.
  - Rosemary will they be getting a new proposal or will they use the same company.
    - Janet indicated that VCOA will be using the same company ... the company has committed to do the work next spring.

#### 5. <u>Financial Reports</u>

- Revenue was added to Budget vs Actual
- Financial report is very strong
  - o Road Account and a portion in interest bearing accounts.
    - Capital in MM and CD.
- All in one bank moving some funds at the end of the year so funds are insured
- Budget vs Actual
  - Budget based on historical trends after Webb contracts were reviewed and modified the scope of work and reduced some of the past expenses.
    - Saved money in Webb contract
- Projecting expenses and revenue could have retained earnings \$57-90k
  - This will help with 2025 Budget and Road Expenses.
- Road \$446,000.00 Cost Sharing agreement we only pay based on actual expenses.
  - New bid -\$550k .... New share would be an extra \$100k
    - Was not a complete bid.
  - o New contract next spring .... At least \$100k or more divided by 43 lots ...
- Don accounting .... Should be easier .... If a quarterly rather than middle of October.
- <u>Ted ...can</u> retained earnings for the road project
- John. yes or it can be used to replace the trees
  - o The trees can be paid by the Capital based on the Capital Reserve Account
- Ted = strongly encourage the Board to replace all the trees at the same time for expediency purposes.
